Fundamental law and fundamental human rights and freedoms. Hierarchy of legal norms in the Constitution of the Republic of Albania. Property rights and those of economic nature. The action of legislation in time and space. Understanding the interpretation of the law and its types.
2	Legal relationships Understanding the elements. Object, subject and content of the legal relationship. Types of legal relationships.
3	Representation Understanding the types and characteristics of representation. Representation without tags.
4	Commercial law, nature and its resources History of commercial law. Nature and sources of commercial law. Applicable trade legislation in Albania.
5	The concept of trader and the categories of companies Simple societies. Company of persons (Collective/limited partnerships). Limited liability companies. Joint stock companies.
6	Public-Private Partnerships (PPPs) and concessions Understanding public-private partnership (PPP) and concession. Purpose, scope and main terms of the Albanian legal framework on concessions and PPPs. Concession and PPP handling structures.

7	Public procurement Meaning and concept of public contract. Electronic procurement Albanian concept and legislation. General public procurement rules. Standard tender documentation, complaint and administrative review.
8	Competition Legal framework in the framework of competition protection. Abuse of a dominant position. Competition Authority (CA) and its activity. Judicial protection. State aid and its impact on competition.
9	Legal action, obligations and civil-legal contracts Meaning and types of legal actions. Understanding of the obligation and basic knowledge about its elements, non-fulfillment, means of securing the fulfillment of the obligation and its extinction. Meaning and types of legal-civil contracts. Elements of contracts, their interpretation, categories.
10	Ownership and business connection Understanding the ownership. The main elements. Co-ownership, protection of property. Ownership and business.
11	Agrarian Law The concept of Agrarian Law. Legal regime of land in different periods of government of the Republic of Albania.
12	Domestic and foreign private investments in Albania Reforms that facilitate investment and increase competition. Special protection for foreign investments.
13	Alternative means of resolving disputes in the field of trade Understanding alternative means of resolving disputes in the field of trade. Types of alternative means of resolving trade disputes.
14	Arbitration Understanding Arbitration. Conflicts that can be resolved through arbitration. Ad hoc and institutional arbitration. The difference between institutional and internal arbitration. The trend of arbitration in the world.
